

purchase and sale of intellectual property assets in bankruptcy! - this report addresses the purchase and sale of intellectual property in a bankruptcy case from the perspective of the potential purchaser. a hypothetical set of facts has been created to highlight many of the hurdles and potential pitfalls that parties may face in attempting to purchase and sell such assets in a bankruptcy case.
